Current Food & Litter

<u>Litterbox Instructions</u>: Use a jumbo plastic litterbox with NO cover. Do NOT use plastic litterbox liners. Do NOT use a mechanical litterbox. Use the Current Litter written above. You may experiment with different litterboxes and litter after the kitten/cat has been using its litterbox perfectly for several months.

As part of this agreement, the Buyer will provide responsible care for the cat/kitten as follows: (1) correct grooming and bathing required for the breed, (2) all needed veterinary care, (3) protection from possible hazards

such as dogs, small children, household chemicals, etc. (4) an environment free of parasites, and (5) under no circumstances allow this cat/kitten to freely roam outdoors.

Please be aware that a cat is a living, breathing creature like yourself, and as such can not be guaranteed to never become ill. Illness, unfortunately, is a possibility in life. All cats, either purebred or not, are subject to disease. Genetic diseases and defects may or may not be detectable through definitive testing that is accurate or available. However, as a responsible breeder we strive to identify and remove inherited problems whenever possible through those means available to us. We ask that our buyers be committed to the well being of the Exotic and Persian breeds by communicating to us any health issues that arise in kittens/cats obtained from us. As part of our commitment to our buyers we guarantee our kittens against death from inheritable disease in the first four years of life. If veterinary diagnoses suggests that an inheritable disease or defect was the cause (written veterinary diagnosis required), a replacement from a different breeding combination will be offered.

We also guarantee our cats free from Polycystic Kidney Disease (PKD), as well as, the viruses, Feline Leukemia Virus (FeLV) and Feline Immunodeficiency Virus (FIV). If blood work is performed on the initial veterinary examination which confirms that either virus may be present, and these findings are confirmed by two unrelated laboratories (copies of test results required), a complete refund of the purchase price will be given upon return of the kitten/cat to us (shipping costs are the responsibility of the buyer). Be aware that "snap" testing done in the veterinary office for these two viruses is highly susceptible to false-positive results. Confirmation of positive results must be made by both the laboratory of the snap test manufacturer and an unaffiliated laboratory. Seller will not be responsible for costs of testing beyond the \$75.00 stated below.

Due to the current status of the FIP and the FIV vaccinations, we highly recommend that our kittens/cats NOT be vaccinated with them. And if given, be administered well after the kitten is established within its new home and well after all other vaccinations have been given. All guarantees will be null and void if the FIP or FIV vaccinations have been administered. Be aware that at this time FIP is still being studied. It is felt that it is a mutation from the common Corona virus for which there is no vaccination. There is much evidence that stressing the immune system with multiple vaccines, viruses and environmental stressors raises the possibility of FIP. We do take steps to minimize Corona infection, however, there is no way to prevent FIP.

Seller reserves the right to be notified and receive the first opportunity to reclaim and/or assist in the new home placement of this cat/kitten, should the Buyer/Owner decide to relinquish his/her ownership.

Seller guarantees that this cat/kitten is free of disease, to the best of the Seller's knowledge, at the time of sale. Seller shall allow the Buyer three (3) calendar days for the initial veterinary examination and confirmation of health. Should the licensed veterinarian diagnose, through examination and/or testing, disease, other than stress induced minor upper-respiratory infection, the Buyer shall have the option to either: 1) immediately return the kitten for full refund (shipping cost not included), or 2) receive compensation for veterinarian prescribed medications and follow-up office visits resulting from the diagnosed illness, up to the amount of \$75.00 (written veterinary diagnosis and receipts required). Otherwise, this cat/kitten is sold "as is", no other guarantees regarding the physiological development, or otherwise, are expressed or implied unless otherwise stated in writing as part of this contract.

The laws of the State of California shall govern the validity, construction and performance of this Agreement. Any legal action required to enforce the terms of this contract will be brought forth in Riverside County in the State of California.
